

# DYSA Background Check and SafeSport

Important things to note:

- All volunteers must register on the [DYSA website](#) as a volunteer first. Without this, your info will NOT be sent to USA Softball
- Data is sent to USA Softball weekly on Mondays. If you sign up on Tuesday, your data will not be sent over until the following Monday and you will not be able to begin your BG/SS until Monday
- Managers (Head Coaches), Assistant Coaches and Dugout moms need to do BG/SS
- Scorekeepers, field prep, team parents do NOT need to BG/SS since they do not interact with children on the field
- The USA Softball “year” runs Sep 1 to Aug 31. If you’ve done BG/SS for Fall season, you are already cleared for the following Spring. All volunteers must renew BG/SS every Fall
